

DR. MILTON M. SHULMAN, DDS

A SALUTE TO NEARLY 60 YEARS
SERVING IN THE HILTON COMMUNITY

Dr. Milton M. Shulman, DDS, has been in the business of general dentistry in Hilton for nearly 60 years. This is quite an accomplishment considering that Dr. Shulman is 88 years young! The good doctor is still "steady as ever" and says that he will only quit working when he begins to shake. Such a dedicated individual deserves to be recognized and saluted for his service in the Hilton community for more than half a century.

Dr. Shulman began his practice in Hilton in 1949 working a full time shift that often included working evenings. He currently runs the oldest existing business, with the original proprietor, still in operation in Hilton. Over the years he has served a great many people,

including residents of Hilton and other surrounding communities. Doctor Shulman began his practice in the small flatiron building located at 1 East Avenue,

East Avenue, and has remained there ever since. Even at the age of 88, he still actively serves several hundred patients. New patients are always

welcome. Although Dr. Shulman no longer offers specialized services such as tooth extractions, he still provides general services including fillings, crowns, bridges, dentures, and partials. Services he no longer provides are quickly referred to a specialist. Dr. Shulman employs 2 dental hygienists to clean teeth, take x-rays and perform various other duties. Currently the Doctor puts in a two and a half day work week with office hours on Mondays and Wednesdays from 8 to 11 am and 1 to 4pm, and on Fridays from 8 to 11 am.

While reminiscing about his years in Hilton, Dr. Shulman vividly recalled the village fire of 1965. He witnessed the horrible tragedy of the destruction of many of the

surrounding businesses in the village, while, by a twist of fate, his own building was spared by a simple shift in the wind. One other business that survived the fire and is still in operation from

that era is that of Pete McCann Insurance Agency. "I remember Pete's father and grandfather running the business back then," recalls Dr. Shulman.



Times have changed, along with the face of our village, but an important part of Hilton's history remains and willingly continues to serve the people of the community today; the practice of Dr. Shulman.

Dr. Shulman currently resides in the city of Rochester with his wife of 60 years, Harriet. In addition to his dentistry practice, Dr. Shulman is solely responsible for the care of his wife who is handicapped and completely dependent upon him. Together, the Shulmans have two adult sons whom they are very proud of, Mark and Dean. Mark is an Anesthesiologist in Boston, at St. Elizabeth Hospital, and Dean is a doctor of Acupuncture in San Diego, California.

A heart felt congratulations to Dr. Shulman for 59 years of service... and still counting, in the Hilton community. May you enjoy continued good health and prosperity in the Village of Hilton.

THILTON TRANS



In August 2008, a year-long transportation study of the Village of Hilton's Main Street district came to completion. The study was commissioned by the Genesee

Transportation Council and conducted by SRF & Associates, Ingalls Planning & Design and Steinmetz Planning Group. An Advisory Committee was formed consisting of officials from the Village of Hilton, officials from the Monroe County DOT and the New York State DOT, a representative from the Hilton-Parma Chamber of Commerce, the Village Public Works Superintendent, the School District Director of Transportation and local business professionals. Community involvement was both encouraged and implemented. The purpose of the study was to develop transportation

planning and design concepts to improve circulation, accessibility and parking in the central business district for pedestrians, bicyclists and motorists

The study began with a public design workshop in August of 2007 where residents and committee members took a walking tour, made observations and critiqued the transportation system. A community transportation survey was given to the public as a part of the planning process. In May of 2008 a second public meeting was held to discuss recommendations and feedback from the community.

The professional consultants advised those involved in the study to set goals to determine desired improvements that would meet the future transportation needs of the Village. The results of the community survey along with input

from the study consultants helped to formulate the following goals:

- 1. Increase safety especially for pedestrians and bicyclists
- 2. Promote walking & bicycling
- 3. Reduce speeds on roadways entering the Village
- 4. Maintain current vehicular access and capacity levels
- 5. Maintain parking supply and convenience
- Improve aesthetics and community character by adding transportation enhancements.

These six goals came with the following recommendations for implementation: first, enhance the appeal of Main Street by adding flush decorative pavement, widening the existing sidewalks, adding new trees and enhancing safety crosswalks with countdown

pedestrian signals. In addition, add decorative plantings and visuals along the

bridge.

Study the future possibility of a multi-use trail development along Salmon Creek, with the addition of two pedestrian bridges that would cross the creek. Also, develop sidewalks along both sides of East Avenue near the High School; bicycle lanes on East and Lake Avenues to enhance the existing 5 mile bike route, along with adding future bike lanes on South, West and Lake Avenues. Visual enhancement recommendations call for the addition of trees on East Avenue and benches, trash receptacles, ash urns, bike racks and planters on Main, Hovey and other high level pedestrian areas. Pedestrian and bicycle safety improvments could be

facilitated by forming a safety advisory board, assigned to an existing group such as the Village Planning Board. Additional recommendations include the conversion of Hovey Street to a oneway northbound (enter only) entryway, in an effort to significantly improve the safety and efficiency of the intersection at Main and Hovey Streets. Hovey Square parking is suggested to be reconfigured for a safer and more convenient north to south route. A new roundabout is proposed at Village II Drive to control speed, right of way, and enhance safety while providing traffic calming benefits. Roundabouts are said to cause fewer conflict points, lower speeds and make decision making easier with less delay.

Recommendations for implementating the proposed

improvements could occur over a time period of 3 different levels of importance: immediate term (0-5 years), medium term (5-10 years) and long term (10-20 years). The survey summary helped to determine what suggestions were a high priority, and what could wait. Many of the immediate recommendations could be implemented as part of the lowcost, maintenance programs already in the Village. Medium term improvements require more planning and funding to implement. The long term improvement recommendations are generally more expensive and are likely to require significant planning and special funding such as a Capital Improvement Program.

While many recommendations have been made, nothing has been set in stone. The next step in the process will be a general meeting, to be held by the end of the year, with the 3 Village Boards and the Village Public Works Superintendent, to discuss which suggestions to implement, determine a time-line of priorities, discuss a budget and develop an implementation plan. Stay tuned for further updates.





On February 17, 2009, older analog televisions will

no longer be capable of receiving network broadcasting signals without the purchase and installation of a digital-to-analog signal conversion box. If your television receives its signal through cable or satellite or another type of pay-tv, you will continue to receive programming after February 17th without interruption. If your television relies on rabbit ears or a roof top antenna for reception you must either purchase a conversion box, or replace your television set.

The Village is preparing for a large number of television sets to be discarded. As a means of providing residents with an environmentally friendly way to dispose of their television sets and other electronic items, the Village of Hilton and Sunnking Recycling Center will be providing a collection program for such items. 

decrease in solid waste disposal over the span of 20 years, while the population has increased by an estimated 23 %. This decrease in solid waste has made a huge impact on helping to reduce the carbon footprint in our community, as well as the financial cost and landfill tonage.

Great job, people!

As with everything, we still have room to do even better! The greatest amount of recyclable materials that are still being put into landfills are paper products such as junk mail, newspapers, magazines, books, etc. The Village would like to challenge residents to be even more vigilant with the paper products that are being put into trash cans. Reminders:

Do not bag leaves

WINTER PARKING RESTRICTIONS



No vehicle shall be parked on any public highway within the corporate limits of the Village of Hilton between the hours of 12:00 midnight and 6:00 a.m. during the period beginning November 1st and ending April 1st of each year. Please be respectful of this Village law and be courteous to those who work hard to keep our streets free of

snow. Violators run the risk of having their vehicle towed at owner's expense.

KEEP STREET CLEAR OF SNOW

A reminder that plowing, shoveling or blowing snow into a public street is **illegal**. This law also applies to contractors hired by homeowners. Driver and pedestrian safety can easily be compromised by snow piles that become dangerous obstacles on a roadway. Be considerate of others when you are removing snow from your driveway.

Do not leave garbage cans or recycling bins in the path of the snowplow or sidewalk plow. Place them in your driveway apron between the sidewalk and street.

ROADSIDE SNOW BANKS POSE HIDDEN DANGER FOR KIDS

Inform your children about the dangers of playing on roadside snow banks and making tunnels in piles left in cul-de-sacs. Children are dangerously concealed and hard to see to a person plowing the roadway and to other motor vehicles. For the safety of all, **prohibit** your children from playing on or in such snow banks. Children should also be advised to wait for the school bus in the driveway away from the sidewalk during plowing operations.

CHECK YOUR MAILBOX

Check the condition of your mailbox and make sure that it is sturdy enough to withstand the impact of flying snow resulting from snow plowing. Most mailbox damage is from the snow exiting the plow, not from the plow itself. Only mailboxes that are actually hit by a plow will be replaced and only standard mailboxes will be provided, not designer styles.


SEWER SYSTEM STUDY UNDERWAY

In late October, the Village of Hilton Public Works Department

began a study of the sewer systems in the village to determine if repairs or upgrades are necessary. The study and following project has been assigned to **Mike McHenry**, Assistant Superintendent of Public Works.

Village crews have been busy cleaning, inspecting and video taping the 8" sewer main from Salmon Creek, behind the fire hall on South Avenue, up to the property located at 263 South Avenue. A





special sewer video camera that is shared between the Brockport Spencerport and Hilton communities is being used to video tape the pipe at this site. Thanks to **Tom Tilebein**, Superintendent of Public Works, the Village secured an \$11,150 Community Development Block Grant, a program of the U.S. Department of Housing and Urban Development(HUD), to go to bid in early November to hire a contractor who will clean and video tape the much larger sewer main West of Salmon Creek Park, following the creek to the South Avenue bridge. This section requires a larger camera, with extended facilities to properly examine the 18" sewer pipe. Following the study, upgrades and improvements will be considered.

PARMA SPECIAL POLICE

Since the formation of the Parma Special Police in 1962, the volunteer organization has served the Hilton-Parma community during special events, emergencies and disasters. The organization has provided traffic control for local events that include the fireman's Carnival, the Hilton Apple Festival, the Parma Summer Festival and homecoming weekend at the high school.

In more recent years, the organization, funded by the Town of Parma, has received special training, which they maintain to proficient level in order to support a safer community. With the addition of new members over the last 3 years, Parma Special Police now have a force of 14 officers. The organization has been able to expand their role in the town and village to cover local soccer,

basketball and wrestling tournaments. With the purchase of bicycles they have been able to include patrols in the expanded town park and in the

village proper. Last year their officers put in over 1,000 hours of volunteer time while on duty. The organization's desire is to act as eyes and ears for the Monroe County Sheriffs department and be a proactive group. They will, when necessary, take action to help minimize injury or damage to property. Local merchants and residents have expressed positive comments for the special police work they have performed.
