Have you ever been inspired by someone helping another in need? Bill Bellman is one of those people who inspires.

After surviving a serious battle with cancer, in thanksgiving for a new lease on life, Bill decided he wanted to give back and pass his blessings on to others in need. For the past 14 years he has been doing just that, by generously giving of his time, talents and personal finances to care for sick, injured and orphaned animals in and around the Hilton-Parma area. He began by becoming a licensed New York State Wildlife Rehabilitator.


As required by New York State, Bill began his journey to become a Wildlife Rehabilitator by taking a few training classes. After passing a final exam, he became licensed, working under the guidance of the DEC (Department of Environmental Conservation). Bill is one of a handful of volunteers within Monroe County willing to help animals. Wildlife rehabilitation is not funded by the state, nor is it a paid position, and so as a volunteer, Bill has had to personally provide for such things as shelter, food, medicine, veterinary care and other incidentals. No fee is charged for the

services Bill provides. His help comes from the bottom of his heart. He welcomes, and is thankful for, any support he can get. In the past, high school students have spent community service hours assisting Bill with his work. Contributions of canned cat food, dog food, venison meat or monetary support is greatly appreciated. A retired senior citizen, Bill is hoping more volunteers will be motivated to step-up and eventually fill his shoes.

To assist a sick, injured or orphaned wild animal, or to obtain more information on becoming a licensed volunteer visit the website www.dec.ny.gov/animals/83977.html and click on "find a wildlife rehabilitator near you", then select your county and the species of animal in need, then click the "search" button. Please take note that not all rehabilitators may be able to accept every injured or orphaned animal due to limited space or resources. Some restrictions apply.

Public Safety - A Top Priority in the Village!

School has been back in session for a few weeks now. In the village we are stepping up our efforts to remind drivers to stop for school busses and watch for children walking and crossing the street. Please commit the following items to memory when operating a motor vehicle.

- Be vigilant watching for children walking or biking to school in the early hours of the morning especially before the sun comes up.
- When backing out of a driveway, be sure the sidewalk is clear of pedestrians before crossing.
- Slow down and watch for children walking in the street or crossing, especially in cross walk zones.
- Be alert for yellow flashing lights which indicate that a bus will be stopping to load or unload children. Motorists should slow down and prepare to stop.
- Red flashing lights and an extended stop sign indicate that a bus is stopped and children are getting off or on. **All** motorists must stop and wait until the red lights stop flashing and the extended stop arm is withdrawn, and the bus begins moving before they may start to drive again.

Another safety concern involves the village sidewalks. Sidewalks were designed to keep citizens out of the street by giving them a safe alternative for walking. Many of the village sidewalks are often blocked with parked cars, forcing pedestrians, and those who rely on electric scooters for mobility to enter the street to bypass the cars. This can be dangerous and puts others at risk. Please be considerate. Don't block the sidewalk with a motor vehicle. Also, please remember that pedestrians *always* have the right of way in a crosswalk.

Solar Farms on the Rise

With the support of New York State, solar power has become a popular source for renewable energy in our area. You may have noticed the recently developed 17,000 panel solar farm that went up on Manitou Road. Another solar farm has been proposed for an area along Burrirt Road.

Village officials are in support of lowering the carbon footprint in the Hilton community through the use of alternative energy. They encourage residents to understand that solar power is an option that is available, and can be taken advantage of, if desired.

Homeowners who consider solar power as an option need to understand that when a person subscribes to energy produced from a solar farm the electric they receive will still be delivered through RG&E. Solar energy, converted from the sun, is fed into the electric grid system and contributes to the power that RG&E distributes. The power source is not entirely solar. It is important to understand how this will affect your billing. Be sure to ask questions.

Update on the New Village Comprehensive Plan

Work has been progressing in the development of a new Comprehensive Plan for the Village of Hilton. The steering committee is now into its sixth month of the scheduled year long process. Community members have had three opportunities to share their thoughts with the committee. Following are some highlights of the work the committee has been facilitating:

1. A public survey was sent out in the community with 266 returns, averaging about a 10% response.
2. A public meeting was held on June 27th. Approximately 30 people, including the committee, were in attendance. Participants were encouraged to engage in four different visioning exercises; the first included mapping what they love about Hilton; the second included mapping what elements of the village they would like improved; the third included listing financial priorities and how they would invest in the community; and the fourth was taking an analysis of the strengths, weaknesses, opportunities and threats to the community.




3. A riding tour of the village was taken on September 11th by the committee.
4. A second public meeting was held on September 26th. At the time this newsletter went to print, the second meeting had not yet taken place.

In addition to the public meetings, committee members have had several additional meetings to review the data received and are currently looking forward to developing the fine details of the plan. Presently a vision statement is being worked on and core values are being developed.

Development Restricted By FEMA For 135 South Avenue



Public input for the new Comprehensive Plan has stirred up many suggestions regarding the property at 135 South Avenue, the site of the former Hilton fire house. Village officials would like to educate the community on the restrictions that have been incurred on that property by the Federal Emergency Management Agency.

In 2009 a hazard mitigation grant, administered by The New York State Division of Homeland Security and Emergency Services (NYS DHSES) and funded by the Federal Emergency Management Agency (FEMA), was obtained by the Village of Hilton and the Hilton-Parma Fire District to partially fund the demolition and removal of the flood-prone fire hall. With the acceptance of the grant money, to protect lives and reduce the impact of future disasters, FEMA required future stipulations regarding the use of the property. The stipulations are as follows:

1. the property must forgo all future development and must be maintained in accordance with open space management standards.
2. Approval must be acquired by FEMA and NYSDHSES for any recreational or open space related development on the property.
3. Regular reports documenting compliance with the open space requirements must be made including photographs.

The portion of the property that has been restricted from development is the former building and parking lot area where the fire house was once located. The remaining part of the property, known as the carnival grounds, is privately owned by the Fire Department Inc. and is not public property.

Village officials appreciate all the input and suggestions from the community, but in regards to this property, the restrictions that are placed on it put future development out of our control.

Saturday, May 18th was a special day for the Parma Hilton Historical Society. 170 members of the community were in attendance at a gala event, held at the Firemen's Exempt Club on South Avenue, in celebration of the Societies' 50th anniversary.

Distinguished guests at the event included the New York State Historian, Devin Lander, and Monroe County Historian, Carolyn Vacca. Lander noted in his comments that he attends many of these events throughout the state and was impressed by the robust turnout for Parma Hilton. He commented on New York State's historical initiatives to interest young students, as well as tourists, genealogists, and others in our unique historical record over the past 381 years.

Edward Gable, former Parma Hilton Museum Curator and presently Museum Registrar, authored a commemorative booklet on the history of the Society. David Almeter and David Crumb authored another book, released on the evening of the gala, on the Parma Hilton time line from the beginning, 1638-2019. The book is available for sale at the Village of Hilton Community Center, The Parma Town Hall and the Parma Hilton Historical Society Museum, for \$15.00.

The Society, originally chartered in 1969, held its first meeting at the home of, then Village Historian, Leith C. Wright, on Gorton Avenue. Twenty five interested local citizens were in attendance. By August 1, 1969, when the official charter was received, there were 103 members. Today, after 50 years, the Societies' membership stands at 142. Of the original charter members, at the time of the banquet, there were 9 still living and 8 active.

The Parma Hilton Historical Society Museum is located at 1300 Hilton Parma Corners Rd. It is opened to the public on Sundays from 2:00 pm - 4:00 pm, from April through November. Be sure to make a trip to see some of the interesting, authentic artifacts from the history of your community.



Please keep children off road-side and cul-de-sac snowbanks & off sidewalks when the sidewalk plow is in use.


