Brief Description of Proposed Action (include purpose or need): The proposed action involves development of a Department of Public Works (DPW) storage and material handling facility on an approximately 14-acre parcel located at 165 Collamer Road in the Village of Hilton, Monroe County, New York. The purpose of the project is to support municipal operations through improvements to the existing site access and operational areas, expansion of material storage capacity, and associated site infrastructure upgrades. Proposed improvements include enhancements to the existing site entrance from Collamer Road, expansion and reconfiguration of internal access drives and operational areas, designated storage areas for materials such as salt, sand, and mulch, and associated vehicle circulation and material handling areas. Material storage areas will consist of precast concrete block bins situated on paved or otherwise stabilized surfaces. Additional improvements include site grading to establish appropriate drainage patterns and construction of stormwater management facilities to treat and convey runoff in accordance with applicable stormwater management requirements.

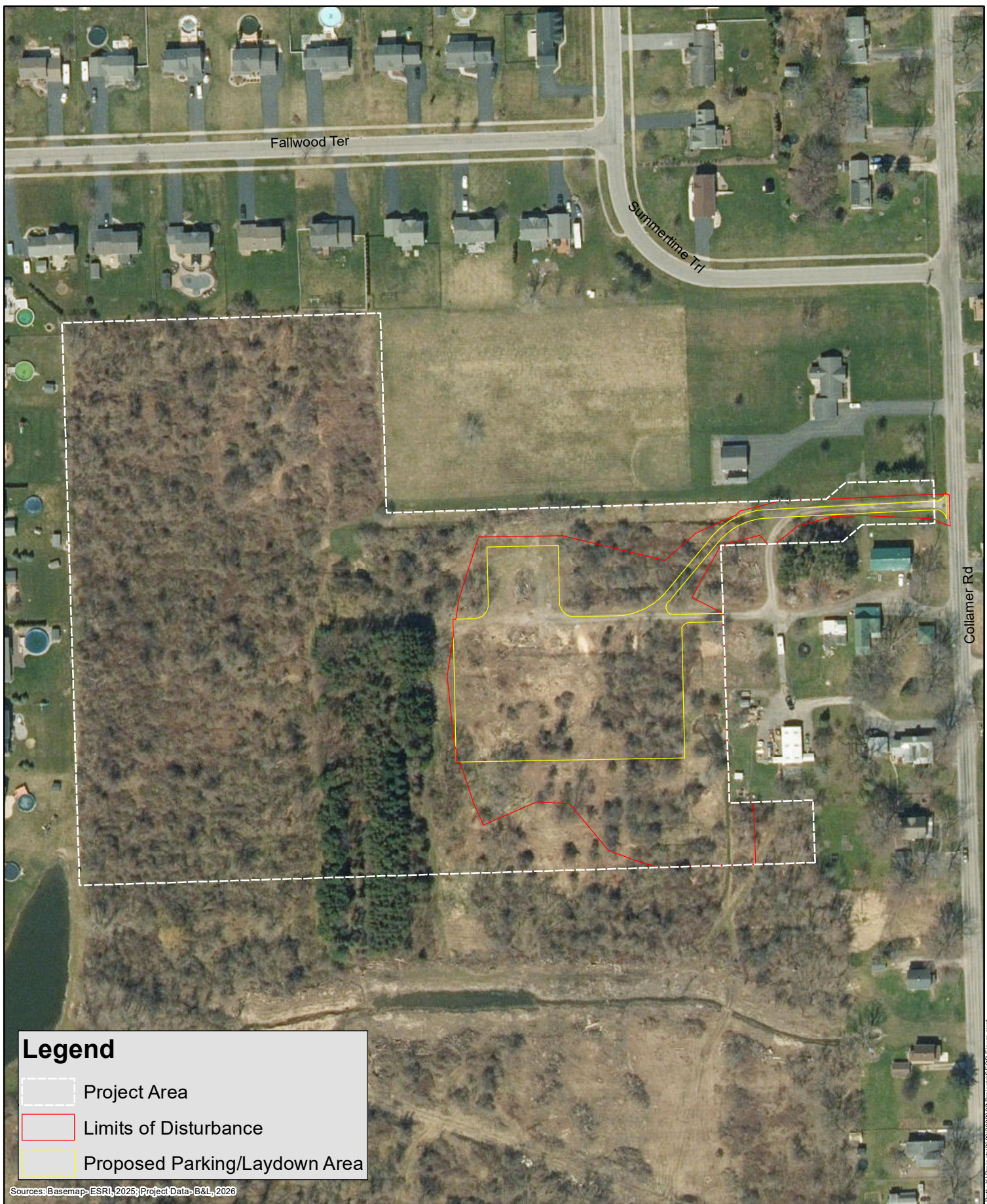

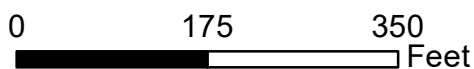

An evaluation of the magnitude and importance of project impacts was completed. Part 2 questions resulting in Moderate to Large impact ratings are further detailed and analyzed below.

1) Impact on Land: a. The proposed action may involve construction on land where depth to water table is less than 3 feet.

A moderate to large impact was identified because a numeric threshold was exceeded. Information concerning depth to water table was collected from Web Soil Survey; specific site conditions may vary. Best management practices outlined in the SWPPP will be followed during construction to prevent adverse impacts, should the contractor encounter a shallow water table.

3) Impacts on Surface Water: b. The proposed action may result in an increase or decrease of over 10% or more than a 10 acre increase or decrease in the surface area of any body of water. A moderate to large impact was identified because a numeric threshold was exceeded. The proposed action involves filling of an existing on-site pond. The pond is not expected to be state or federally regulated. The proposed stormwater management facilities will provide adequate runoff management and water quality treatment for the site. No significant adverse impacts to surface water resources are anticipated.

Potential small impacts were identified for additional Part 2 questions. These items are briefly discussed below.

1) Impact on Land: f. The proposed action may result in increased erosion, whether from physical disturbance or vegetation removal (including from treatment by herbicides).

Construction-related ground disturbance may temporarily increase erosion on site. All work will be done in accordance with the project's SWPPP and applicable NYSDEC SPDES General Permit requirements. Disturbed areas will be permanently stabilized following construction activities.

3) Impacts on Surface Water: a. The proposed action may create a new water body; d. The proposed action may involve construction within or adjoining a freshwater or tidal wetland, or in the bed or banks of any other water body; e. The proposed action may create turbidity in a waterbody, either from upland erosion, runoff or by disturbing bottom sediments; and h. The proposed action may cause soil erosion, or otherwise create a source of stormwater discharge that may lead to siltation or other degradation of receiving water bodies.

A new stormwater management basin will be constructed to capture and treat runoff from the site. As discussed above, an existing small pond on site will be filled as part of the site re-grading. Erosion and sediment controls will be implemented during construction to ensure that turbid runoff is adequately captured and treated on site to prevent water quality impacts.

5) Impact on flooding: d. The proposed action may result in, or require, modification of existing drainage patterns.

Existing drainage patterns on site will be modified in accordance with the design plans (new asphalt pavement and associated site grading). As discussed above, a new stormwater basin will be constructed to capture and treat sheet flow runoff from the expanded development on site. No significant adverse flooding impacts are anticipated.

7) Impact on Plants and Animals: b. The proposed action may result in a reduction or degradation of any habitat used by any rare, threatened or endangered species, as listed by New York State or the federal government; and g. The proposed action may substantially interfere with nesting/breeding, foraging, or over-wintering habitat for the predominant species that occupy or use the project site.

The USFWS reported the northern long-eared bat, tricolored bat, and monarch butterfly for the project site. The NYSDEC did not report any protected species records for the site. A small amount of tree removal (about 1.1 acres) will be required. The Village may impose voluntary tree removal timing restrictions (removal between November 1 and March 31) to reduce potential adverse impacts to the protected bat species. This would also avoid clearing during the common breeding season for common wildlife species that may occupy the site.

9) Impact on Aesthetic Resources: c. The proposed action may be visible from publicly accessible vantage points: i. Seasonally (e.g., screened by summer foliage, but visible during other seasons) and ii. Year round; d. The situation or activity in which viewers are engaged while viewing the proposed action is: i. Routine travel by residents, including travel to and from work; and f. There are similar projects visible within the following distance of the proposed project: 0-1/2 mile 1/2-3 mile 3-5 mile 5+ mile.

Construction activities may be visible to people travelling along Collamer Road and nearby developed properties, particularly during leaf-off conditions. The proposed action is consistent with existing municipal operational land uses within the area; the site is already used by the Village DPW for material storage. No significant adverse aesthetic impacts are anticipated.

15) Impact on Noise, Odor, and Light: a. The proposed action may produce sound above noise levels established by local regulation.

Temporary increases in noise may occur during construction and site operations associated with heavy equipment use. Construction and routine site operations will be limited to daytime, weekday work hours. No significant adverse noise impacts are anticipated.
